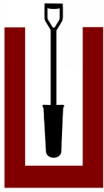

This full day course will define the term “enforcement” as it is used in the Sewage Facilities Act and the regulations. It will review a range of available enforcement actions and the most appropriate times or circumstances to use them. This presentation will explore the laws impacting septic system installation, with a focus on requirements beyond the PA Sewage Facilities Act (Act 537). Instructors will emphasize the importance of responsible septic system installation and compliance with other environmental laws and regulations. Topics to be discussed include erosion and

sedimentation, riparian buffers, wetlands, endangered species conservation, and PNDI clearances. Participants will gain valuable insights into mitigating environmental impacts while ensuring the successful implementation of septic systems, ultimately contributing to the preservation of water quality and the protection of vital ecosystems.

Tank Buoyancy and Anti-Flotation Measures

An important consideration in the installation of septic, pump, or holding tanks is the risk of flotation due to the presence of groundwater above the bottom of the tank. The goal of this presentation is to prompt regulators, designers, and installers to think about buoyancy for the installation of any tank installation. When a rigid object such as an empty septic, pump, or holding tank is partially or fully submerged in groundwater, an upward force is exerted on the object that is equal to the weight of the displaced groundwater. This presentation will develop two very simple models for evaluating buoyant force. Engineering controls, such as ballast systems, concrete pads, and helical anchors and associated best installation practices are evaluated. This presentation will include a discussion of Archimedes' principle, basic geotechnics of buried tanks, uplift forces, buoyancy control function, and buoyancy control best practices.

Installation of Onsite Wastewater Treatment Systems – Training Course DAY 2

At-grade absorption areas are an alternative to elevated sand mound systems and are approved for use in PA as an alternate system. The focus of this half day, 3-credit course will be to describe the technical concept and site testing requirements for at-grade absorption areas particularly in comparison to elevated sand mound systems. General design criteria will be presented as well as more detailed absorption area design elements for both the level and sloped at-grade absorption areas. The importance of equalizing flows for sloped systems will be discussed as well as construction and installation techniques, SEO inspections, and system maintenance. Completion of the seminar officially delegates SEOs to independently review and issue permits or at-grade absorption areas.

East Derry **Challenges of Treating High-Strength Wastewater**

Frank Parker, Parker Wastewater Consulting; Craig Morris, ALL4HIM Septic Inspections

Wastewater is usually defined as high strength when concentrations of BOD, TSS, FOG, or nitrogen are higher than typical domestic wastewater. The focus is commercial and non-residential water usages that lead to unusual or high wastewater strengths. These include restaurants, truck stops, breweries, etc. Many states now recognize that the treatment of high BOD₅, TSS, or FOG concentrations requires different strategies than those used for typical domestic applications. Several pretreatment possibilities exist, but the extent to which they reduce high-strength wastewater is not fully understood. Treatment must not only reduce wastewater strength, but also bring effluent quality into conformity with stringent discharge limits. Highly variable conditions and limited operator knowledge in decentralized applications mean that treatment systems must be simple, flexible, reliable, and robust. Premier Tech tested and adapted approaches to reach different treatment levels.

West Derry **Septic System Submission Reviews: Tips and Best Practices for Onsite Wastewater Professionals**

Often Wastewater Professionals will run into questionable non-sewage related situations as part of their customer service interactions with property owners. This program will focus on presenting telltale signs of illegal activity allowing the professional to notify the proper authorities if they so choose. The program will be focused on ensuring the safety of the Wastewater Professional.

West Derry **Why Systems Fail**

On lot sewage dispersal systems fail for three basic reasons: improper permitting; improper installation and improper management. Even the term "failed" is often misused. An unsatisfactory PSMA inspection is not in all cases a system failure or malfunction that warrants a complete system replacement. This session will explore the reasons for an unsatisfactory PSMA conclusion when it relates to the dry aggregate rule. It will present some alternatives to consider for the rehabilitation of the system. An evaluation protocol will be presented to assess the feasibility of rehabilitation versus the complete replacement of the system.

Susquehanna **Inspection Reports – The Good, The Bad, & The Ugly**

One of the crucial aspects of an on-lot wastewater treatment inspection is the inspection report. This session will look at a variety of reports that have come to our attention, the good and the bad, and even the ugly. We will explore what makes a good report and a not so good one. How does the PSMA Inspection Standards direct the inspector to format his or her report? The use of templates in reports and a look at what is useful and what is not.

Harrisburg **Lyme & Other Tick-Borne Diseases**

Doug Fearn, LymeBasics.org

This presentation will help attendees understand how one gets Lyme disease, how to recognize its symptoms, and what treatments may be required. In addition to Lyme, there are varied coinfections that may also be transmitted by ticks. New tick-borne diseases are being discovered all the time, and some established diseases are being diagnosed more often. The program will cover emerging tick-borne diseases – both bacterial and viral – that cause somewhat different symptoms than Lyme disease but are also carried by deer ticks and can be transmitted after only 15 minutes of tick attachment. For some, there is no treatment, and those who survive usually suffer from long-term, serious neurological damage.

CONTINUING EDUCATION

Continuing education credits are available for those attending the 2024 Onsite Wastewater Super Conference of Pennsylvania.

Upon checking-in at the Conference Registration Desk, you should have received an **“Attendance Documentation Form”** listing all the sessions you signed up for. If you are seeking PSMA, SEO, or other continuing education credits, you must have each session moderator stamp your Attendance Documentation Form to verify your attendance at that session.

At the conclusion of the Conference, please return the Attendance Documentation Form to the Registration Desk for processing. Without this form we cannot report your continuing education credits.

If you are attending of the formal training courses, the course instructor will have a separate sign-in sheet in the classroom for you to document your attendance. For these courses only, use the sign-in sheets instead of the Attendance Documentation Form.

PSMA SRI Credits:

Those PSMA-certified inspectors enrolled in the SRI Program can earn continuing education credits. PSMA/NOF 101 Basic, 102 Advanced, & 103 Experienced inspector certifications do not require continuing education credits -- only SRI certification. One PSMA SRI continuing education credit is awarded for each conference breakout session attended for a maximum of 8 credits. If you are taking a formal training course on Sunday, Monday, and or Tuesday, they are worth three SRI credits for a half day, six for a full day, or twelve for a 2-day course.
